ECO-PARTICIPATION MODULATION AND SUPERMODULATION

The eco-participation for certain equipment can be modulated according to the criteria specified in the "Modulation criteria" column of this contribution scale. 2 additional supermodulation criteria allow you to benefit from premiums that will be calculated separately from the contribution scale via a specific declaration:

#1 The "Reparability index" criterion for equipment marked with a green arrow (→) or the "sustainability index" criterion for equipment marked with an orange arrow (→) for which the premium is €8.33 excl.VAT or €16.67 Excl.VAT, depending on the equipment. In accordance with Annex II of the Order of September 5, 2025, establishing modulations applicable to financial contributions paid by producers when they incorporate recycled plastics, the premium linked to the reparability index or to the sustainability cannot be granted to a product subject to a penalty.

#2 The "Incorporation of Recycled Plastic Materials (RPM)" criterion for equipment incorporating plastic resins, calculated on the basis of the total mass of RPM incorporated into the equipment within 2 levels of premiums depending on the origin of the recycled materials:

- For RPM derived from post-consumer waste from EPR systems (Open Loop), excluding food-grade resins, the calculation base is established on the basis of €450/t excl. VAT, to be reduced to the mass of RPM of the equipment.
- For RPM from post-consumer WEEE (Closed loop), the calculation base is established on the basis of €550/t excl. VAT to be reduced to the mass of RPM in the equipment.

The products concerned will have to be the subject of a pre-declaration, reference by reference and after validation by ecosystem, premiums will be paid after the declaration of your real put on market equipment.

*** Any person who manufactures, imports or introduces household electrical and electronic equipment onto the national market professionally, as well as the successive purchasers of these equipment, must indicate on the sales invoices for all new household electrical and electronic equipment, all the way to the end user, in addition to the unit price of the product, the unit cost incurred for the management of separately collected waste from household electrical and electronic equipment. This unit cost is equal to the cost of managing this waste. It cannot be subject to any reduction. Purchasers pass on this cost to the final customer. Customers are informed of this at the point of sale or, in the case of distance selling, by any appropriate means. A decree by the Council of State specifies the conditions of application of provision I and the penalties applicable in case of infringement (Article taken from decree R.543-205 of the Environment Code).
