## ECO-PARTICIPATION MODULATION

Eco-participation modulation criteria have applied to professional EEE according to the conditions below:

- For all EEE containing at least 20% plastic by mass and containing flame retardants:
  - **Criterion 1 PREMIUM "Absence of Bromine in plastic parts containing Flame Retardant (BFR)"**  
absence of bromine in all plastic parts of more than 25 grams containing flame retardants, excluding electronic cards and power cables.
- For all EEE mentioned below:
  - **Criterion 2 PREMIUM "Availability of spare parts"**  
for a period equal to the following period, for each equipment type eligible:
    - Refrigerating appliances with a direct sales function: 10 years;
    - Chest freezers: 15 years;
    - Electronic displays: 10 years;
    - Welding equipment: 15 years;
    - Emergency lighting systems: 10 years;
    - Printing systems: 6 years;
    - UPS (Uninterruptible Power Supply) < 50 cm: 10 years;
    - UPS (Uninterruptible Power Supply) ≥ 50 cm: 12 years;
    - Generating sets: 10 years;
    - Screwdrivers, drills, chisels: 17 years;
    - Valve gearmotors: 10 years.

- For all EEE containing batteries or accumulators:
  - **Criterion 3 PENALTY "Non-separable Battery";**
- For all EEE containing plastic resins:
  - **Super modulation:** "Integration of recycled plastic" criterion generating a Premium calculated on the basis of the total mass of recycled plastic materials (RPM) incorporated into the equipment.

**Prerequisite:** for a RPM to qualify for a premium, it must be derived from the recycling of waste collected or supported under an extended producer responsibility (EPR) scheme.

**2 levels of premiums are established according to the origin of the recycled material.**

- For MRP from post-consumer waste, excluding food-grade resins the calculation base is established on the basis of €450/t excl. VAT, to be reduced to the mass of the equipment.
- For RPM from post-consumer WEEE, the calculation base is established on the basis of 550€/t excl. VAT to be reduced to the mass of RPM of the equipment.

The amount of the premium must be calculated reference by reference, in compliance with the rules of the OCAD3E technical note. The products concerned will have to be the subject of a pre-declaration and after validation by **ecosystem**, the declaration can be made at the same time as the declaration of marketed products.






